PRIMARY ROUTES OF ENTRY & EFFECTS OF OVER EXPOSURE:

Eyes: Contact with liquid concentrate may cause severe eye irritation accompanied by stinging, tearing, redness and pain. Prolonged overexposure to vapors may cause moderate irritation. May aggravate existing eye conditions.
